



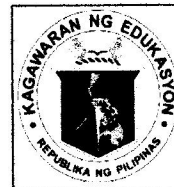
SUBJECT: FIRST SECONDARY PUBLIC SCHOOLS FRIENDLY DEBATE TOURNAMENT CUP

1. To develop the speaking competences and critical reasoning of the students of the public secondary schools of the Department of Education of the Division of Baguio City, a **FIRST SECONDARY PUBLIC SCHOOLS FRIENDLY DEBATE TOURNAMENT CUP** shall be conducted. This event is an activity of the **PINES CITY NATIONAL HIGH SCHOOL** in coordination of the DepEd-Baguio City.
2. Objectives of the said debate tournament are as follows:
 - a. promote debate as a tool to strengthen communicative skills of the students
 - b. develop analytical teamwork among student
 - c. instill the importance of cooperative learning among the public secondary schools
3. All public secondary schools may send a maximum of fifteen (15) debaters or five (5) teams. Observers are also encouraged.
4. Teachers who will participate are entitled for a two (2) day service credits and two day compensatory overtime credits (COC) for the non teaching personnel for the services rendered on Saturday and Sunday (October 20-21, 2012).
6. Registration fee of Php50.00 shall be charged per debater and Php20.00 per observer for the honoraria of judges.

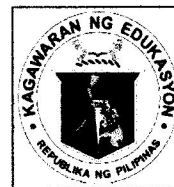

Tournament Cap: **50 TEAMS, FIRST COME-FIRST SERVED BASIS**

Registration Fee: **PHP 50.00 each debater**

PHP 20.00 each observer

Deadline of Confirmation: **October 12, 2012**

TOURNAMENT GUIDELINES

1. Preliminary rounds will be composed of three rounds.
2. Matches for round 1 will be determined at random while succeeding round will be determined through power matching.
3. A 30-minute preparation time will be allotted for each round.
4. Electronic devices are not allowed during the preparation time.
5. Any team is not allowed to confer with other teams or with their coach once the motion is given.
6. Adjudication will be given right after the match and adjudicator's decision will be final.
