





1. The Philippine Guidance & Counseling Association- Baguio-Benguet Chapter (PGCA- BBC) will conduct its **Fourth Regional Guidance Forum** on Thursday, November 29, 2012 at the University of the Cordillera Theatre Hall, Baguio City from 7 o'clock a.m. to 5:00 p.m. The forum shall dwell on the theme "**The Guidance and Counseling Profession in Perspective – Part 2**"
2. Aware of the need to intensify the understanding of RA 9258 and committed to realize the professionalization of Guidance and Counseling, PGCA-BBC conceptualized the forum in order to create better awareness, orient and familiarize Schools Division Superintendents, District Supervisors/in-charge of districts, Principals, School Administrators and Guidance Counselors-practitioners of public and private schools about the implementation of the RA 9258 or the Guidance and Counseling Act of 2004 and its implications to the administration and supervision of guidance and counseling services. 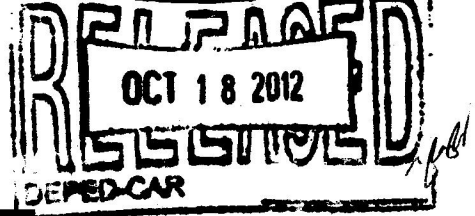

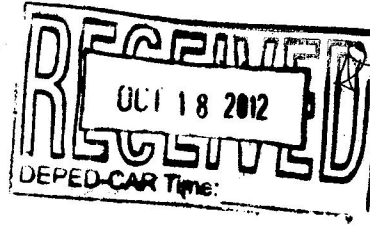
