- 1. This is to inform the field that a Division Tournament in batted balls will be held on September 28, 29 and October 5-6, 2013 at the Baguio Athletic Oval. The opening ceremonies will be on September 28, 2013 at 8 AM in the same venue.
- 2. Participation to this tournament is open to all baseball and softball teams of public and private elementary and secondary schools. All school heads are encouraged to send as many teams as they can afford as this will benefit the school, faculty, pupils and students.
- 3. The objectives of this tournament are as follows:
- a. Develop coaching skills among the coaches and playing strategies among the athletes.
- b. Develop teamwork among all members of a team.
- c. Apply rigorously all acquired playing and coaching skills.
- e. Appreciate the game of batted balls.
- 4. A registration fee of Php100 shall be charged to each participating team to cover—expenses on certificates and other incidental expenditures. This fee can be charged from any available sources, school and PTA funds subject to usual accounting and auditing procedures
- 5. A four-day service and certificate of overtime credits shall be granted to public school teachers, coaches and administrators and non-teaching personnel respectively who will be involved in this tournament.
- 6. All participating teams shall wear their own playing attires with the proper assigned color to distinguish one team from the other and for their own comfort.

## THE 2013 INTERSCHOOL "AWENG TI PASKUA" CHRISTMAS CHORAL COMPETITION SPECIFIC GUIDELINES, RULES AND REGULATIONS

- 1. The competition is open to all choral groups/glee clubs from the public schools in Baguio City. The competition will be on December 4, 2013. Venue shall be announced soon.
- 2. Participants are limited to minimum of twenty five (25) and maximum of thirty (30) singers, excluding one (1) accompanist and one (1) conductor. Each choral group shall fill-out the registration form attached hereon that shall be submitted to the office of Dr. Fernando D. Eleponga on or before November 15, 2013. There shall be a registration fee of two hundred pesos (P200.00) to be attached on the registration form.
- 3. There shall be two songs to be rendered by each choral group. First to be performed is the warm-up piece and the other song is the contest piece.
- 4. The chosen piece shall be chosen personally by each of the competing groups. It shall serve as warm-up piece. It could be an a cappella or with accompaniment as required by the piece. Additional accompanists and/or instrumentalists as may be required by the warm-up piece should come from within the choir members. However, the warm-up piece will not be adjudged and does not have bearing to the score of the choral groups.
- 5. The given piece will serve as the contest piece. It is attached hereon. It will be sung immediately after their rendition of their warm-up piece. The official given or contest piece is JUBILATE DEO by GORDON YOUNG. It should be sung a cappella. Moreover, the contest piece will be adjudged basing on the following criteria:

TECHNIQUE (Intonation, Diction, Choral Blend and Balance)	- 50%
ARTISTRY (Interpretation, Expression and Style)	<b>– 30%</b>
COSTUME	<b>– 10%</b>
OVERALL PERFORMANCE	- 10%

- 6. Each choir will be given a maximum time of ten (10) minutes to perform the two required pieces. Timer starts when the first note of the warm-up song is sung and timer ends with the cut-off of the last piece.
- 7. Any choral group exceeding the maximum time limit allotted for their performance will be penalized as follows:
  - More than thirty (30) seconds over time allotted 1 point subtracted from cumulative score
  - One (1) to two (2) minutes over time allotted 2 points subtracted from total cumulative score
  - More than two (2) minutes over time allotted 3 points subtracted from total cumulative score
- 8. Winning choirs (1<sup>st</sup> Place, 2<sup>nd</sup> Place, and 3<sup>rd</sup> Place) will receive trophy while all participating choirs will receive Certificate of Participation.
- 9. The order of performances will be determined by the drawing of lots on the competition day itself.
- 10. Non-submission (whether deliberate or accidental) of any or all of the above mechanics will constitute a valid reason for disqualification.
- 11. It is understood that the organizers of this competition shall not be held liable for any untoward incident(s) which may involve participants who are minors and are in the custody of their group leader(s) for the course of the competition.







