- 1. This is to announce to the field that the Laro ng Lahi (Elementary Kadang-kadang and Secondary Sanggol) Division Elimination for CARAA 2014 will be held on January 21, 2014 from 8:00 AM to 5:00 PM at Quezon Elementary School.. All District MAPEH Coordinators are requested to assign at least two (2) officiating officials for each event. For the Secondary Demonstration Sports (Wrestling, Billard, Wushu and Futsal) the division elimination must be on or before January 21, 2014. - 2. The participation of all Districts (District I, District II, and District III) is encouraged
- 3. The following documents must be submitted to the District MAPEH Coordinators on or before the Division Elimination for screening purposes: a. AR1, b. Photo copy of Birth Certificate or NSO, c. Parents' Consent, d. Certificate of Enrolment, e. Medical Certificate f. Dental Certificate and **ENTRY FORM**.
- 4. All coaches and athletes shall be excused from their classes during the division elimination.
- 5. Only Working Committee Members, Officiating Officials, Coaches, Trainers, Chaperons and Athletes are excused from their classes during the Division Elimination. School heads should make the necessary arrangements to ensure continuation of classes in the absence of teachers who are involved in the activities mentioned above.
- 6. All technical officials, coaches/co-coaches/trainers of the Demonstration Sports and Laro ng Lahi and District PESS coordinators will meet on January 20, 2014 at 3:00 PM at the Division Office Conference Hall. Training of selected athletes shall commence right after the selection until the 2014 CARAA proper.
- 7. The Event Tournament Manager & the secretary and the Champion Coach shall have the final say on the composition of the team for the 2014 CARAA.
