An important feature of the program is; It will be conducted Free and the immediate issuance of National Certificate or Certificate of Competency to the successful candidates.

In this regard, we are inviting all Trainers from your member-schools to undergo assessment in Bookkeeping NC III, Bread and Pastry Production NC II, Bartending NC II, Cookery NC II, Computer Hardware Servicing NC II, Food and Beverage Services NC II, Food and Beverage Services NC III, Front Office Services NC II, Housekeeping NC II, Horticulture NC II, Security Services NC II, Automotive Servicing NC II and NC III, Driving NC II and NC III, Carpentry NC II, Electrical Installation and Maintenance NC II. Masonry NC II, Flux Cord Arc Welding NC II, Gas Metal Arc Welding NC II and Shielded Metal Arc Welding NC II.

However, the applicants should download the Self Assessment Guides or Candidate's Guide and Application Forms from the TESDA website (www.tesda.gov.ph). These Self Assessment Guides or Candidate's Guide will determine if the candidate can perform the tasks stated in the qualification applied for. These forms will be filled-up by the applicant prior to their application. Only applicants who positively answered the Self Assessment Guides or Candidate's Guide are qualified for free assessment.

We will appreciate very much if your Trainers and workers can file their applications on or before May 12, 2014 at the TESDA-CAR Regional Training Center, Loakan Road, Baguio City and Baguio City School of Arts and Trades, Upper Session Rd., Baguio City . The names of your trainers/workers will be submitted to TESDA Central Office. We have limited slots so availment will be on a "First come first served basis".
