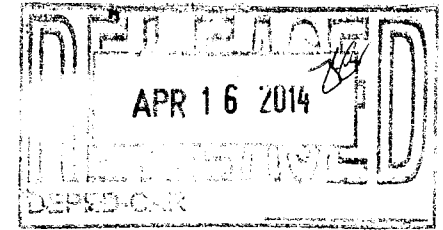
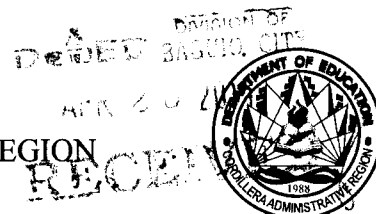

**REITERATING COMPLIANCE TO DEPED ORDER NO. 8, S. 2007 RE: REVISED  
 IMPLEMENTING GUIDELINES ON THE OPERATION AND MANAGEMENT OF  
 SCHOOL CANTEENS IN PUBLIC ELEMENTARY AND SECONDARY SCHOOLS**

1. In order to safeguard the health of the school children, students and including the school staff, the implementing guidelines of DepEd Order No. 8, s. 2007 ( Revised Guidelines on the Operation and Management of School Canteens in Public Elementary and Secondary schools) shall be complied and monitored strictly. This order includes the Private Elementary and Secondary Schools in the region.
2. The schools division superintendents, regional/division education program supervisors, school heads and health personnel are enjoined to monitor on what is being sold in the school canteens. It is within the school heads accountability to adhere to the implementing guidelines and to ensure that safe and nutritious foods are being served in the school canteens.
