

We are happy to announce that the 3rd installment of the SDC, annually hosted by the Northern Luzon Debate Council, will be held on February 20-22, 2015 at various premises of Saint Louis University.

Since the SDC was envisioned as an avenue to develop the field of debating and public speaking in the whole of Northern Luzon among High School Institutions, a new development in the competition will be introduced for this year. This is the establishment of the Northern Luzon High School Debate Circuit which is the first High School Debate Council in the whole of Northern Luzon, under the supervision of the Northern Luzon Debate Council (specifically under Saint Louis University), with the objective of creating an active debating circuit for high school students patterned from the structure and activities of the Philippine Debating Union.

In the planned Summit to create the envisioned High School Circuit, some of the major matters that will be discussed includes:

- Ratification of the Constitution and By-Laws of the High School Circuit;
- Election of Officers among the Attending Participants; and
- Introduction for the Bidding System of the Northern Luzon Debate Summit (similar to the National Debate Competition of the Philippine Debate union).

On the other hand, the debate competition aspect of the event will utilize the Asians Parliamentary Debate Format with a team cap of three (3) teams per participating institution. Also, the tournament will be opening a public speaking category among interested participants who will be competing for the debate category.

A Registration Fee of Php. 400.00 per person will be collected for each participant for their Debate Primer and Journal and for their 3 Day Lunch Meals during the duration of the event.

HISTORY OF SDC

Genesis:

With the ultimate goal of spreading the culture of debating in the whole of Northern Luzon, the pioneers of debating in the Northern Luzon (primarily, from SLU) established the *Louisian Debate Education Program (LDEP)* which provides mentoring and training for interested college and high school institutions within Northern Luzon.






For years, LDEP was implemented and has resulted to the creation of various debating societies in the college and high school levels. The collegiate phase of LDEP resulted to the further creation of the *Northern Luzon Debate Council (NLDC)*, formerly Baguio Debate Council, which serves as the active regional unit for Debating in Cordillera Administrative Region, Region I and Region II.

The high school aspect, however, have seem to backlog when it comes to its development in the current updates in the methods and style of debating as observed by the National and International Debating Community. So that, the Northern Luzon Debate Council established the SDC as an avenue for NLDC to pass its continuous developing science and art of debating among high school students in a competitive debating sport.

As such, the Birth of SDC was witnessed on the Month of January 2013.




Exodus:





ASIANS PARLIAMENTARY FORMAT

I- Format

SDC 2015 will be following the Asian Parliamentary format. Speakers are given seven minutes each to deliver their speech, with a 20-second grace period to allow for wrapping up. A marshal warns the speaker after the first minute with a single tap, after the 6th minute with another tap, and after the 7th minute with two taps. In the time interval between the two single taps (ie, after the first minute and before the end of the 6th minute), debaters from the opposing bench are allowed to raise **Points of Information** or POIs. POIs are given by a speaker from the opposing side for a maximum of 15 seconds, after which the speaker or the marshal may opt to cut short the POI.

Prime Minister

- o The PM gives the setup of the debate. He/she
 - defines of the motion
 - determines the issue that directly pertains to the motion
 - gives the parameters (ie, the place, parties involved, legislations, etc)
 - gives the theme or general idea of the opening team's speeches and the case split
 - builds his/her own case
 - summarizes his/her case

Deputy Prime Minister

- o The DPM extends the case of the PM. He/she
 - rebuts the case of the previous speaker
 - fulfills his/her part of the split
 - summarizes his/her case

Government Whip

- The GW is the last speaker of the Government side. He/she
 - rebuts the cases of the constructive speakers of the opposition side
 - summarizes the cases of the OG and highlights the case of the Member of Government



- o The LO gives an effective clash against the government. He/she
 - accepts the definition given by the Prime Minister if it is debatable and provides a new one if it is not gives the clash and the case split
 - rebuts the case of the previous speaker builds his/her case
 - summarizes his/her case

Deputy Leader of Opposition

- o The DLO extends the case of the LO. He/she
 - rebuts the case of the previous speaker
 - fulfills his/her part of the split summarizes his/her case

Opposition Whip

- o The OW is the last speaker of the Opposition side. He/she
 - rebuts the cases of the constructive speakers of the government side
 - summarizes the cases of the OO and highlights the cases of the Member of Opposition

Negative Reply Speaker

 Gives a biased adjudication of the debate for the Negative side by encouraging the adjudicator to give them the win

Affirmative Reply Speaker

- Gives a biased adjudication of the debate for the Affirmative side by encouraging the adjudicator to give them the win
 - ** The Asians Parliamentary Format follows the following speaker role arrangement:
 - o First Speaker: Prime Minister
 - Second Speaker: Leader of Opposition
 - o Third Speaker: Deputy Prime Minister
 - o Fourth Speaker: Deputy Leader of Opposition
 - o Fifth Speaker: Government Whip
 - Sixth Speaker: Opposition Reply
 - Seventh Speaker: Opposition Reply (Either LO or DLO)
 - Eight Speaker: Government reply (Either PM or DPM)


