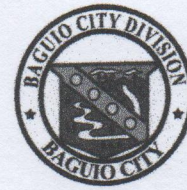


Administration of 2016 English Proficiency Test for Elementary, Junior High and Senior High Teacher I Applicants
