

## INVITATION TO BID

Project No.: 001-2016

The Department of Education (DepED) Division of Baguio City, through the 2014 Government Appropriations Act (GAA), intends to apply the sum of One Million Five Hundred Thousand Pesos only (PhP $1,500,000.00$ ), being the Approved Budget for the Contract (ABC), to eligible payments under the contract for the Repairs / Rehabilitation of PFVR under the PFVR Fund. Bids received that exceed the ABC per lot shall be rejected at bid opening.

The DepED Division of Baguio City, through its Bids and Awards Committee (BAC), now invites bids for the above-mentioned works. Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent ( $50 \%$ ) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Govemment Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy five percent ( $75 \%$ ) interests or outstanding capital stocks belonging to citizens of the Philippines.

A complete set of Bidding Documents may be inspected or purchased at the DepED Division of Baguio City BAC Secretariat, located at \#82 Military Cut Off, Baguio City upon accomplishing a bidder's information sheet and payment in cash of a non-refundable fee by interested bidders in the amount of One Thousand Five Hundred Pesos Only (PhP $1,500.00$ ) to the DepED Division of Baguio City Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).

It may be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS), www.philgeps.net, and the website of the Procuring Entity, www.depedpines.com provided that bidders shall pay the fee for the Bidding Documents not later than the submission of their bids.

The DepED Division of Baguio City reserves the right to reject any and all bids, declare a failure of bidding, not award the contract(s), or annul the bidding process without thereby incurring any liability to the affected bidder or bidders.
