**TRAINING-WORKSHOP ON CONTEXTUALIZATION AND INDIGENIZATION OF
CURRICULUM AND SCHOOL IMPROVEMENT PLAN (SIP)**

1. Pursuant to DepEd Order No. 62, s. 2011, Indigenization does not only talk on teacher, classroom, learning space and management practices but most especially on the culture-based curriculum. Relative to this, there will be a Training-Workshop on Contextualization of Curriculum and School Improvement Plan Phase II on July 28-30, 2016 to be held at Brentwood Hotel and August 4-7, 2016 at Santa Catalina Spirituality Center, Marcos Highway, Baguio City.
2. The purpose of this Training-Writeshop is to:
 - a. enhance the capacity of participants to formulate the curriculum/learning competencies for Indigenous Peoples (IP) learner and School Improvement Plan (SIP)
 - b. Develop their ability to interface the IP curriculum with DepEd curriculum
 - c. Prepare culture based-curriculum for the IP learner
 - d. Eliminate any form of discrimination found in some of the learning materials.
3. Participants and matrix of activities to this training please see (inclosure 1-2, D.O. 198. 2016)
4. The participants are requested to bring along with them laptop, learning competencies and textbook of the subject they are teaching. Also bring the IKSPs of the Cordillera provinces.
5. Teacher participant and non-teaching personnel will be granted three (3) days service credits/COC for services to be rendered on July 30, 2016 and August 6-7, 2016 that falls on Saturdays and Sundays respectively. School heads are expected to see to it that classes of these affected teachers will be taken cared well. Teacher-prepared modules will be of great help to fill-in the gap cause by the absence of the teacher.


