## TEACHERS TRAININGS SURVEY

- 1. Section 3.2.11 of the Implementing Rules and Regulations (IRR) of the Governance of Basic Education Act of 2001 or the Republic Act 9155 states that: Consistent with the national educational policies, plans and standards, the Regional Director shall have authority, accountability and responsibility in planning and managing effective and efficient use of all personnel, physical and fiscal resources of the regional office, development and establishments of procedures in monitoring and supervision of divisions/ schools physical and fiscal resources, including professional staff development of the region.
- 2. Human Resource Development Section of the Division of Baguio City with the full support of the Human Resource Development Division of the DepEd Regional Office are continuously undertaking activities for the professional development of the Division's human resource, where Training development Information System and the Individual Performance Development Plan are the basis for identifying competency gaps that needs to be addressed through trainings, seminars, scholarships, coaching and mentoring.
- 3. The HRD Section of the Division is using both TDIS and IPDP and are both constructed for Department use of both teaching and non-teaching personnel. Both forms are relevant tools in organizing training needs of teachers, but a continuous monitoring and evaluation of trained and untrained teachers is necessary.

In light of the foregoing statements, the Division Office through the HRD section issues the following localized training survey forms attached (enclosure 1 and 2) to have a complete data on general and specific professional development needs of teachers and identify teachers who are in need of trainings.
