

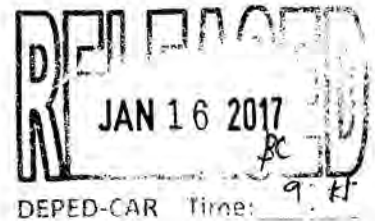



REGIONAL ACCREDITATION FOR SPORTS OFFICIATING OFFICIALS

To: All Schools Division Superintendents

1. The Department of Education DepEd-CAR through the Education Support Services Division will conduct a Regional Accreditation for Sports Officiating Officials in coordination with Baguio City High School, Baguio City on January 20-22, 2017.
2. The objectives of the Accreditation are:
  - a. to accredit qualified school sports officiating officials to officiate in school sports competitions;
  - b. to update them on the latest trends, rules and regulations on the respective sport disciplines;
  - c. and to upgrade and improve their competencies in managing and officiating in school sports competitions.
3. The experts of the nationally accredited Deped officials and the local National Sports Association in the region will be tapped to be the resource persons for their respective sports events as follows: *Arnis At* Archery, Athletics, Badminton, Baseball, basketball, Billiard, Boxing, Chess, Football, Futsal, Gymnastics, Lawn Tennis, Sepak Takraw, Softball, Swimming, Table Tennis, Taekwondo, Wrestling, Wushu, and Volleyball. Each School Division Office will send Five (5) participants per sports event. Only those who are sent by their Division Offices will be accommodated.
4. The participants must meet the following requirements:
  - a. must be physically fit
  - b. must not be more than 50 years old as of January 2016
  - c. must possess knowledge and skills in their respective field of sports discipline
  - d. must have officiated in the Division/City athletic competition
  - e. must bring their complete sports attire and racket equipment (for racket events) for practicum.
5. This sports Accreditation shall mainly consist of theoretical lectures on the rules of the sports, practical application, paper and practical examination and physical fitness test.
6. A registration fee of Four Hundred Pesos (400.00) shall be collected from each participant to defray expenses for honoraria, meals and snacks of lecturers/speakers, Xerox of brochures, rental of playing venues, janitorial services and other incidental expenses shall be paid in cash to the Baguio City High School during the registration. The registration fee and transportation expenses of the each participant is chargeable against local/school/ or any other sources of funds subject to the usual accounting and auditing rules and regulations.
7. Immediate dissemination of this Memorandum is enjoined.




