To : All Private Secondary School Heads

Date : February 20, 2017

1. Pursuant to Deped memorandum no.16 s.2017 The Department of Education (Deped).Through the Bureau of Education Assessment (BEA) with The Assistance of Schools Division and Secondary School Personnel, shall Administer the **National Career Assessment Examination (NCAE) for The School Year 2016-2017 from March 1 to 2, 2017 (Wednesday and Thursday)** to all Grade 9 students in both Public and Private Schools nationwide.
2. Only Private Secondary Schools with Permit to Operate from this Department shall be Included in the conduct of the test.
3. Each NCAE examinee (Grade9) shall be issued a Certificate of Rating (COR) will reflect the examinees Preference for Senior High School.
4. Relative to this. School Heads are Required to Submit on February 28, 2017 a narrative Report on the Conduct of School NCAE Orientation 2017.


