



INVITATION TO BID

The Department of Education (DepED), Division of Baguio City, through the PFVR Fund, intends to apply the sum of One Million Six Hundred Pesos only (Php 1,000,600.00), being the Approved Budget for the Contract (ABC), to eligible payments under the contract for the Repair / Rehabilitation of PFVR Building Phase II. Bids received that exceed the ABC per lot shall be rejected at bid opening.

The DepED Division of Baguio City, through its Bids and Awards Committee (BAC), now invites bids for the above mentioned works. Prospective bidders must have an experience of having completed at least one (1) contract that is similar to the contract to be bid, and whose value, adjusted to current prices using the NSO consumer price indices, must be at least fifty percent (50%) of the ABC to be bid. The description of an eligible bidder is contained in the Bidding Documents, particularly in section II, Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships/partnerships, or organizations with at least seventy five percent (75%) interests or outstanding capital stocks belonging to citizens of the Philippines.

A complete set of Bidding Documents may be inspected and downloaded at the www.depedpines.com and can be paid in cash of a non-refundable fee by interested bidders in the amount of Five Thousand Pesos Only (PhP 5,000.00) to the DepED [Division of Baguio City](http://www.depedpines.com) Cashier. Only bidders who purchased the Bidding Documents will be allowed to submit bids (ITB 6.8).
