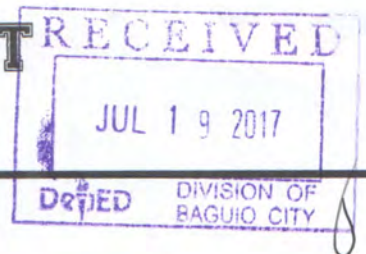

BWD ON-THE-SPOT POSTER MAKING CONTEST

GUIDELINES and MECHANICS

1. This contest shall be open to students from Grades 7 to 10 enrolled in either Public or Private Secondary Schools within Baguio City. Teachers and/or Coaches, if any are encouraged to be present during the contest.
2. Theme: "Water Sustainability and Urban Resiliency: An Approach to Water Conservation"
3. Contestants must bring their own materials for the contest, as follows: ¼ illustration board, pencils, erasers, crayons/colored pencils/poster paints, markers, cotton or tissue.
4. Artworks must be in 'PORTRAIT' orientation.
5. Entries shall be judged according to the following criteria:

Originality, style and creativity	40%
Interpretation and relevance to the theme	40%
Presentation and neatness	<u>20%</u>
Total	100%

6. Prizes

1st prize: P3,000.00 plus medal

2nd prize: P2,000.00 plus medal

3rd prize: P1,000.00 plus medal

**certificates for participating students

7. The decision of the Board of Judges (composed of selected BWD top level management personnel) shall be FINAL and EXECUTORY.
8. Entries submitted to the Poster Contest Committee will become the property of the Baguio Water District and shall not be returned to the artists. BWD acquires the right to reproduce, use, display and exhibit all entries for its promotional activities. The artists also agree to use their names and personal information in BWD's publicity materials.
9. Winners shall be notified by phone/mail, and shall be invited for awarding at the BWD Office.
