- 1. The Alternative Learning System (ALS) aims to provide Rescue and Safety Life Skills to out-ofschool youths and mobile teachers of the different ALS Learning Centers of Baguio City. The training in Rope Rescue (Ropemanship), Rescue First Aid, and Lecture on Fire Safety will be held on September 27-29, 2017 at Baguio Central School, Yandoc St., Baguio City.
- 2. The activity aims to:
 - a. enhance the knowledge and skills of out-of-school youths and mobile teachers on Rope Rescue (Ropemanship), Rescue First Aid, and Fire Safety;
 - b. develop skills for them to be responsible members of their family, community, and the country as a whole:
 - c. help them be confident emergency life savers using the basic life skills and to take action no matter where they are or when it is required:
 - d prepare them to provide the necessary assistance while at home, in the grocery store, on vacation, or wherever an emergency may arise; and
 - e. initiate participants to unfold close camaraderie between and amongst the learners and people involved in the training.
- 3. The participants of this activity would be 33 Selected ALS Learners from the different Learning Centers of the Alternative Learning System in Baguio City, 11 ALS Mobile Teachers, 12 Learning Resource Providers, 1 School Head, and 1 Education Program Supervisor.
- 4. The participants will be having the training at Baguio Central School and will be staying out.
