In undergoing the procedures and processes of crafting school policies on child protection, please be guided in accordance with DepEd Order No. 40, s. 2012; DepEd Order No. 55, s. 2013; DepEd Order No. 18, s. 2015; and the Primer on Positive Discipline in Everyday Teaching, to ensure that important elements will be included as parts of the schools' guiding policy.

 provided by the City Social Welfare and Development Office, located at Upper Session Road
 Extension, Baguio City.
- Lists of Social Welfare Officers in charge per unit are also hereby attached in Enclosure 3, for the schools to contact in case they are in need of assistance in their referrals.
- Submission of finalized Child Protection Policy Manual is due to the Division Office on or before November 6, 2017, and the same would be the basis of monitoring onwards. Please submit the Division Copy to Dr. Juliet C. Sannad, the Division Coordinator on Child Protection.
