#### **RESOLUTION Numbered 198** (Series of 2016)

REQUESTING THE REGIONAL OFFICE OF THE DEPARTMENT OF EDUCATION AND PRIVATE SCHOOLS TO CONSIDER A POLICY OR GUIDELINE FOR THE SUSPENSION OF EXAMINATIONS OR GRADED ACTIVITIES IN SCHOOLS, PARTICULARLY IN PRESCHOOL, ELEMENTARY, AND SECONDARY, IN TIMES OF TYPHOONS, FLOODING, OTHER WEATHER DISTURBANCES, AND CALAMITIES WHEN CLASSES IN THE CITY OF BAGUIO ARE NOT SUSPENDED OR CANCELLED AUTOMATICALLY OR WHEN NO ANNOUNCEMENTS FOR THE PURPOSE WERE MADE THE PURPOSE WERE MADE.

WHEREAS, Department of Education Order No. 43, Series of 2012 [GUIDELINES ON THE IMPLEMENTATION OF EXECUTIVE ORDER NO. 66 (Prescribing Rules on the Cancellation or Suspension of Classes and Work in Government Offices Due to Typhoons, Flooding, Other Weather Disturbances, and Calamities)] recognizes the authority and responsibility of parents in determining the risks their children may encounter in going to school in times of inclement weather, hazards, or calamities;

WHEREAS, the guidelines, in fact, place the determination of risk ultimately on parents as provided in paragraph 2 (h) of guidelines hereunder reproduced to wit:

"2. In compliance thereof, the following guidelines shall be observed by all concerned regional, division, and school officials of both public and private schools:

### "h. Responsibility of Parents

"The DepEd still maintains that parents have the ultimate responsibility for determining whether their children should go to school, even if no order for cancellation/suspension of classes has been issued, if they feel that traveling to or from school will place their children at risks. (Underscoring provided)

"Parents are advised to check for media advisories coming from PAGASA, NDRRMC, RDRRMCs, LDRRMCs or the Office of the President itself.";

WHEREAS, the ultimate responsibility, however, may not be effected because there are times that children will insist to go to school for fear of missing scheduled or announced examinations or graded activities which may affect their academic standings;

WHEREAS, while some schools have adopted a policy allowing special examinations or make-up activities, they are usually found more difficult or that the achievable credit for such are usually lesser compared to those who braved the ill weather;

WHEREAS, unless the fear be cleared, there is no way that full respect to the ultimate responsibility and to the authority of parents can be supported or realized; and

WHEREAS, the system of communications we now have today where parents can easily inform schools of the exercise of their ultimate responsibility will definitely make easy the definition of the parameters of the policy or guideline;

NOW, THEREFORE, on motion of Hon. Fianza, Hon. Yaranon, and Hon. Bomogao, seconded by Hon. Sembrano, Hon. Yangot, Hon. Allad-iw, Hon. Ortega, and Hon. Olowan be it

RESOLVED, as it is hereby resolved, to request the Regional Office of the Department of Education and private schools to consider a policy or guideline for the suspension of examinations or graded activities in schools, particularly in preschool, elementary, and secondary, in times of typhoons, flooding, other weather disturbances, and calamities when classes in the City of Baguio are not suspended or cancelled automatically or when no announcements for the purpose were made.
