RESOLUTION NO. 013, S. 2017

RECOMMENDING THE AWARD OF CONTRACT TO JEFFREY EMIL E. DEE (JEIDINE GEN. MDSE.) RESTORATION OF OFFICIAL VEHICLE MITSUBISHI L300 FOR SUPPLY OFFICE.

WHEREAS, the Department of Education prepared the Purchase Order (PO) and Purchase Request (PR) for the Restoration of Official Vehicle Mitsubishi L300 for Supply Office with an Approved Budget for the Contract (ABC) of **One Hundred Thousand Pesos only (Php 100,000.00)** (Annex A);

WHEREAS, on April 7, 2017, the DepED – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said project. The following suppliers/distributors signified their intent to participate by submitting their respective quotations/proposals;

SPECIAL STAGE AUTO ACCESSORY	Php 138,821.00
RFQ OUTO REPAIR SHOP	Php 150,000.00

WHEREAS, per evaluation of the Technical Working Group, the following are non compliant with the specifications set forth in the TOR:

Supplier/Distributors	Non-compliance
SPECIAL STAGE AUTO ACCESSORY	Quotation exceeds ABC
RFQ OUTO REPAIR SHOP	Quotation exceeds ABC

WHEREAS, on the other hand, the proposal of **JEFFREY EMIL E. DEE** is found to be compliant with the PO, and its price quotation amounting to **One Hundred Thousand Pesos only (Php 100,000.00)** is the most economical and advantageous to the Government, thereby rendering the same as the lowest calculated responsive bid;

WHEREAS, Section 12 of R.A. No. 9184 mandates that the BAC shall recommend the award of the contract to the Head of the Procuring Entity or his/her duly authorized representative.

NOW THEREFORE, for and in consideration of the foregoing, **We**, the Members of the Bids and Awards Committee, hereby **RECOMMEND** to the Schools Division Superintendent the following:

- a) **AWARD OF CONTRACT** via Small Value Procurement to **JEFFREY EMIL E. DEE (JEIDINE GEN. MDSE.)** for the **Restoration of Official Vehicle L300 for Supply Office** in the amount of **One Hundred Thousand Pesos only (Php 100,000.00)** inclusive of appropriate taxes and fees; and
- b) **GRANT OF AUTHORIZATION** for the BAC Chairman to sign the corresponding Notice of Award and Notice to Proceed to implement this Resolution.

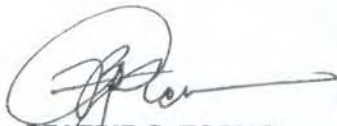

CONTRACT

THIS CONTRACT, made and entered into this 28th day of April, 2017 by and between the Department of Education, *Division of Baguio City*, located at #82 Military Cut-Off, Baguio City represented herein by its *Schools Division Superintendent, BEATRIZ G. TORNO, CESO IV*, hereinafter referred to as the "Entity" of the one part and *JEIDINE GEN. MDSG.*, represented herein by its owner, *JEFFREY EMIL E. DEE*, hereinafter referred to as the "Contractor" of the other part;

WHEREAS, upon the invitation of the Entity, the Supplier submitted a bid for **THE RESTORATION OF OFFICIAL VEHICLE MITSUBISHI L300 FOR SUPPLY OFFICE** in the amount of **One Hundred Thousand Pesos only (PhP 100,000.00)** inclusive of appropriate taxes and fees (hereinafter called the "Contract Price"), which the Entity subsequently accepted pursuant to DepED Bids and Awards Committee Resolution No. 013 series of 2017.

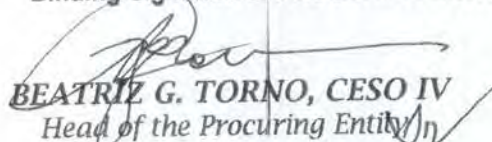
NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - c. The Entity's Notice of Award, attached as **Annex C**.
2. In consideration of the payment to be made by the Entity to the Supplier as hereinbefore mentioned, the Supplier hereby covenants with the Entity to provide the goods, and remedy defects thereof in conformity with the stipulations of the Contract in all respects, without prejudice to any other obligations that may arise pursuant to the provisions of applicable laws.
3. The Supplier shall pay appropriate taxes in full and on time and that failure to do so will entitle the government to suspend payment for any services delivered by the Supplier
4. The Entity hereby covenants to pay the Supplier the Contract Price in consideration of the provision of the goods and the remedying of defects thereof.

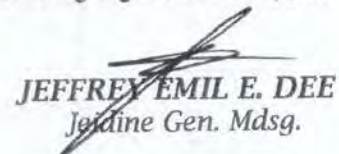
