PERMISSION AND RELEASE FORM

IN CONSIDERATION of being permitted to participate in the basketball game(s), event(s) and other activit(y/ies) scheduled to take place in connection with the 2018 Jr. NBA Philippines program (collectively, the "Events"), the undersigned, on behalf of myself, my participant child or ward (if applicable) (the "Participant"), and Participant's personal representatives, heirs, assigns, and next of kin, hereby:

- irrevocably grant permission to each of the Released Entities (as defined below) to utilize Participant's name, voice, statements, photograph, image, likeness, actions at the Events and/or Participant's biographical data in any live or recorded form (including, but not limited to, any form of video display or other transmission or reproduction), in whole or in part, for promotional, commercial or any other purpose, in perpetuity worldwide in any media whether now known or hereafter created without any additional consideration;
- (a) acknowledge that the Participant's participation in the Events involves risk of serious bodily injury, death, property damage and/or other harm which might result not only from the Participant's actions, inactions, or negligence, but also from the actions, inactions or negligence of others, the conditions of the premises or of any equipment used and that there may be other risks not known or reasonably foreseeable at this time; and (b) accept sole responsibility for all of the hazards and risks to Participant and Participant's property associated with or related to Participant's participation in the Events and for any damage or injury that Participant may cause to others;
- (a) to the extent permitted by applicable law, release, waive and forever discharge any and all claims of damages or causes of action, including but not limited to, death, personal injury or loss or damage to property, which I, the Participant or any of the Participant's representatives, heirs, next of kin or assignees ("Participant Representatives") may have or which may hereinafter accrue to me, the Participant or the Participant Representatives as a result of Participant's participation in the Events or otherwise and which may be asserted by me, the Participant or the Participant Representatives against NBA Philippines, Inc., NBA Asia Limited, WNBA Enterprises, LLC, the Women's National Basketball Association and its member teams, NBA Entertainment, a division of NBA Properties, Inc., NBA Properties, Inc. - understand and agree that (a) Participant's refusal to accept any prize from any Event or other activity shall constitute a forfeiture of that prize and shall release the Released Entities from any and all obligations in connection with such prize; (b) Participant is responsible for and shall pay all state and federal or other taxes as required for by applicable law on any and all cash and/or prizes Participant wins; (c) Participant agrees and acknowledges that the Released Entities reserve the right to withhold any payable taxes from any and all cash or prizes Participant wins to make payments to the relevant tax authorities as required by applicable law from time to time; (d) Participant will indemnify and hold the Released Entities harmless against any liability for any such taxes and agree that any of the Released Entities may deduct or require payment of any such tax before delivery of a prize; and (e) any travel undertaken by Participant in connection with Participant's acceptance or use of any prize shall be taken at Participant's sole risk. **FURTHERMORE, I / PARTICIPANT FULLY ACKNOWLEDGES, APPRECIATES AND UNDERSTANDS THE RISK THAT PARTICIPANT'S PARTICIPATION IN ANY CONTEST, ACCEPTANCE OF ANY PRIZES AND/OR NBAP'S USE OF THE MATERIALS COULD AFFECT ANY HIGH SCHOOL OR INTERCOLLEGIATE ATHLETIC ELIGIBILITY THAT PARTICIPANT MAY HAVE, AND PARTICIPANT FULLY ASSUMES SUCH RISK AND RELEASES THE RELEASED ENTITIES FROM ANY LIABILITY IN CONNECTION WITH ANY SUCH FAILURE TO BE ELIGIBLE FOR HIGH SCHOOL OR INTERCOLLEGIATE ATHLETIC COMPETITION;**
- acknowledge that the Released Entities are relying on the grant of rights contained herein; and
- expressly agree that this Permission and Release Form is intended to be as broad and inclusive as is permitted by all applicable laws and that if any portion hereof is held invalid, it is agreed that the balance shall nonetheless continue in full legal force and effect.
- agree that this Permission and Release Form is governed by, and shall be construed and enforced in accordance with, the laws of the State of New York, United States of America, excluding its choice of law principles. Any claim arising out of, relating to, or in connection with this Permission and Release Form, including any question regarding its existence, validity, or termination, and any question as to whether a particular dispute is arbitrable hereunder, shall be referred to and finally resolved by binding arbitration administered by the International Court of Arbitration in accordance with its International Arbitration Rules ("Rules") by three arbitrators appointed in accordance with such Rules, with the two co-arbitrators having 30 days from the appointment of the second arbitrator to nominate the chair. The place of arbitration shall be New York County, New York, and the language to be used in the arbitral proceedings shall be English. The arbitrators shall award to the prevailing party its costs, including its attorneys' fees, incurred in connection with the arbitration. Judgment upon the award may be entered by any court having jurisdiction thereof. The parties waive irrevocably their right to any form of appeal, review or recourse to any judicial authority, insofar as such waiver may be validly made, with respect to any award of the arbitrators, including interim or partial awards, and including with respect to questions of law. Participant hereby waives in any such arbitration and in any Ancillary Proceedings (as defined below) any defense of lack of personal jurisdiction or forum non conveniens or other similar doctrine. The parties hereby consent to the jurisdiction of the courts sitting in New York County, New York, in connection with any legal proceedings concerning or arising out of any such arbitration (including proceedings to compel arbitration, stay litigation, issue interim measures of protection including attachments, confirm, recognize or enforce an arbitral award, or enforce a court judgment issued on an arbitral award) ("Ancillary Proceedings") and agree that such courts shall award to the prevailing party its costs, including its attorneys' fees, incurred in connection with such Ancillary Proceeding. I HAVE READ AND VOLUNTARILY SIGN THIS PERMISSION AND RELEASE FORM, and further agree that no oral representations, statements or inducement contrary to anything contained herein have been made by NBAP or any of its employees or agents. In the event of any conflict between the English language version of this form and any translation thereof, the English language version shall prevail.
