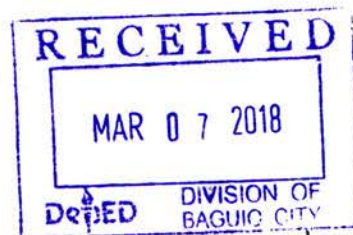

**MARCH 25, 2018 BOARD LICENSURE EXAMINATION
FOR PROFESSIONAL TEACHERS**

The Professional Regulation Commission (PRC) Baguio Regional Office (BRO) and the Board for Professional Teachers will conduct the Board Licensure Examination for Professional Teachers (BLEPT) on March 25, 2018 to a total of twelve thousand six hundred thirty-one (12,631) examinees. Nine thousand eight hundred thirty-four (9,834) examinees will take the BLEPT in Baguio City, and two thousand seven hundred ninety-seven (2,797) examinees in Rosales, Pangasinan.
