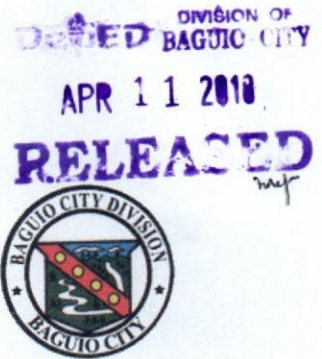

**ADMINISTRATION OF ENGLISH PROFICIENCY TEST (EPT)  
FOR TEACHER APPLICANTS ON APRIL 15, 2018**

New Teacher Applicants

1. Pursuant to DepEd Order No. 7, series 2015, the Department of Education (DepEd) through the Bureau of Education Assessment with the assistance of Division and school personnel, shall administer the English Proficiency Test to new teacher applicants in our division.
2. Relative to this, the English Proficiency Test (with four hundred available slots) shall be conducted at Baguio City National High School on **April 15, 2018**, Sunday at 8:00 AM onwards.
3. The EPT examinees are advised to be at the venue (Baguio City National High School) not later than 7:30 in the morning to have a sufficient time in locating the testing rooms where their names are listed.
4. EPT takers should bring valid identification card (e.g. PRC ID,) and pencil Mongol 1 & 2 with eraser/s.
