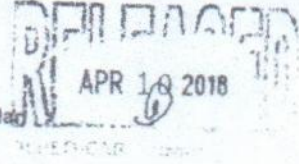

SUBJECT : Revisit/Revalidation of the Senior High School Implementation Plan



1. This has reference to the Issues and Concern regarding the decrease of Senior High School Enrolment for SY 2017-2018 as shown in the enrolment data: (Please see attached PPRD data for reference)

Increased enrollment in Grade 11 Private SHS enrolment from SY 2016-2017 to SY 2017-2018= 715 students or 4.98%	Increased enrollment in Grade 11 Public SHS enrolment from SY 2016-2017 to SY 2017-2018=516 students or 4.13%
