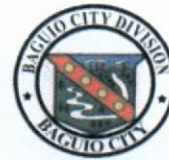


SUBJECT : **BENCHMARKING OF BEST PRACTICES IN THE ALTERNATIVE**
