- Only athletes of **combative sports (boxing, wushu, arnis, taekwondo, wrestling and pencak silat), gymnastics and athletics-track** are to be examined.
- For combative sports Forms 1, 2 and 3 are to be accomplished. Form 2 shall be signed by the parents or guardians of the athlete. For gymnastics and athletics-track Form 1 is only to be accomplished. Use prescribed size of forms (**A4**).
- All coaches shall assist their athletes in securing required forms and in accomplishing the said forms correctly. All forms, parent's consent/waiver and other pertinent documents shall be duly accomplished prior the medical-dental examination.
- All athletes shall present to the medical team with trimmed fingernails, clean cut haircut with no earrings for males and ponytail for females with long hair.

6. All coaches **MUST ACCOMPANY** their athletes to the venue until their examination is done. All District Sports Coordinators must also be present during the examination.
