**POLICY FORUM cum REVIEW on Iloko as Medium of Instruction and as Learning Area under Mother Tongue-Based Multilingual Education (MTB-MLE)**

1. Section 5 of Republic Act (RA) No. 9155, otherwise known as the Governance of Basic Education Act states the shared governance as a principle which *recognizes that every unit in the education bureaucracy has a particular role, task and responsibility inherent in the office and for which it is principally accountable for outcomes.*

The results of educational planning reports, researches, and Division Monitoring and Evaluation (DMEA) indicate that there is a need to revisit the policy of using Iloko as the medium of instruction and as a learning area under Mother Tongue-Based Multilingual Education (MTB-MLE) in the Schools Division of Baguio City.
