

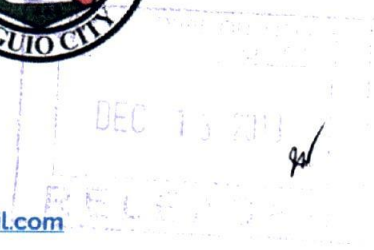

**Subject:** **DEPED-BAGUIO FAMILY DAY**

**Date:** **December 10, 2018**

1. Pursuant to DepEd Order No. 49, s. 2018, the start of the Christmas break shall be on December 15, 2018, amending the earlier date, December 22, stipulated in DepEd Order No. 25, s. 2018 (School Calendar 2018-2019).
2. The intent of D.O. 49 is explicitly expressed in the first paragraph, i.e., **to provide an opportunity for Filipino learners to strengthen their emotional bonds with their family.**
3. In view of the foregoing, the DepEd-Baguio Family Day celebration, previously scheduled on December 21, 2018 shall be held on January 12, 2019 to support the intent of D.O. 49. With the adjustment made, school heads and other concerned officials are advised to be more resilient in scheduling the distribution of Report Cards to preclude rush computation of grades for the third quarter examination.
4. The teachers shall be granted a one day Service Credit (SC) while the non-teaching, teaching-related, supervisors, and school heads shall be granted a one day Compensatory Overtime Credit (COC).
5. The proposed and requested date of DepEd-Baguio Family Day on December 15, 2018 is not in concurrence with D.O. 49 which states that, **“December 15, 2018 shall remain to be a class day intended for student activities.”** Likewise, conducting it on December 14 is tantamount to circumvention of D.O. 49, cognizant of the fact that the number of student-teacher contact hours is already decreased.
6. Conducting the above cited activity within the dates: December 16 to 22 still runs counter to the intent of D.O. 49. Further, trainings for CID, SGOD, as well as OSDS personnel (except teachers) which had been postponed due to intervening higher-office initiated trainings, thus, re-scheduled within the said dates can no longer be postponed.
7. Immediate and widest dissemination of this Memorandum is highly desired.
