- I. Presentation of the members of the BAC and acknowledgement of the presence of the participating prospective bidders.
- II. Presentation of "Annex A" Envelope Sealing Illustration and "Annex B" checklist to be followed which is included in the posting of bid documents and explanation of each item.
- III. Agreements made as to additional instructions attached in the bid document:
 - 1. Follow the Sealing and Marking of Bids (Two-Envelope System) (ANNEX A).
 - 2. All bidders are required to request to join bidding from PhilGEPS for the project.
 - 3. All representatives of interested bidders (sole proprietorship, partnership, or corporation) should submit an authorization from proprietor, general manager or the board of directors.
 - 4. Bidders are advised to get the updated checklist of documents to be submitted during the opening of bids. (ANNEX B)

- 6. For the bid security, cash is discouraged. Bidders may also opt to submit Bid Security Declaration (BSD) aside from those enumerated in item 18.1 of the BDS.
- 7. As to the synchronization of time of deadline for the submission of bids, bidders are instructed to follow the time at the Division Office Biometric Machine.
- 8. Those who bought bid documents are required to notify the BAC if they decide not to participate in the opening of bids.
- 9. Single Largest Completed Contract (SLCC) should have the same major categories of work as Repair / Rehabilitation of School Buildings.
- 10. Bidders who do not meet the requirements specified in the Bid Documents and the Supplemental Bid Bulletin will automatically be disqualified.
- 11. Failure on the part of the bidders to comply with the foregoing instructions or additional requirements shall be a ground for the bidder to be disqualified to join the bidding process.
- IV. Clarifications on other matters.
 - 1. If declared SLCC is more than a year, Certificate of Final Acceptance must be attached.
 - 2. Only SLCC will be declared in the documents to be submitted but contractor should include all on going projects.
- V. Presentation of the technical and financial components of the Bid, including the explanation of the different documents to be submitted by each bidder.

VI. Other Matters:

1. Tabbing of the Bidding Documents, both original and copy one, is requested to prospective bidders to help ensure completeness and for easier facilitation of the examination of the documents.

There being no other remaining topics for discussion, the Pre-bid Conference adjourned at 9:53 AM.
