

REGIONAL ORIENTATION ON THE POLICY AND GUIDELINES ON COMPREHENSIVE TOBACCO CONTROL

- TO: Schools Division Superintendents
 All others Concerned
- In compliance with DO 48, s. 2016, the Orientation on the Policy and Guidelines on Comprehensive Tobacco Control will be conducted at the R-NEAP Hall, DepEd Cmpd, Wangal, La Trinidad, Benguet on January 9-11, 2019, inclusive of travel time.
- 2. The three (3) day Regional Orientation aims to:
 - a. Provide participants with the rationale for tobacco control, which includes the burdens of tobacco use, existing tobacco control policies, and tactics of the tobacco industry to market its products and to interfere with the implementation of tobacco control policies;
 - b. Provide participants with a deeper understanding of DO 48, s. 2016, or the Policy and Guidelines on Comprehensive Tobacco Control: and
