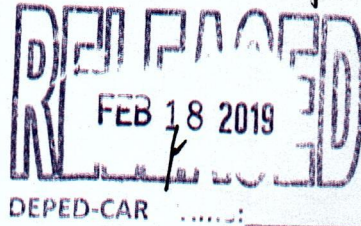
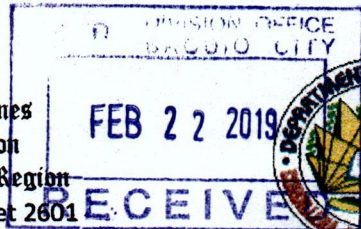

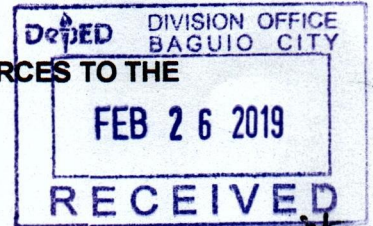

SUBMISSION OF LOCALLY DEVELOPED LEARNING RESOURCES TO THE REGIONAL LRMS

1. Relative to the agreement on the submission of LRs to the Region, the following guidelines are to be observed:
 - a. Thirty (30) LRs plus one (1) ALS locally developed LR from the least learned competencies or critical contents in any Learning area and Grade level per SDO shall to be submitted quarterly based on the following schedule:

Quarter	Date of Submission	Release of Results from LRMS
First	March 15, 2019	May 15, 2019
Second	June 15, 2019	August 15, 2019
Third	September 15, 2019	November 15, 2019
Fourth	December 15, 2019	February 15, 2019

- b. The LRs are expected to be packaged with DLL, and with attachments of the QA Forms CO form 7.10 (IPR), Form 7. 20 (Educational Soundness) Form 7.6 (Evaluation for the development of new print resource) Form 7.8 (Non-Print Evaluation Form) Form 7.14 (Social Content Evaluation) and CAR – QF-CLMD-LRMS -02 (Validation for Contextualization/ Elders Certificate/ FPIC).
- c. Locally developed LRs for quarterly submission are expected to undergo thorough review and quality assurance by the division QA team to facilitate uploading to the portal.
- d. The target of the LRs to meet the standards shall prevail and any variance will cause back log to the SDOs quarterly submission.
- e. LRs submitted December 2018 shall be returned to the SDOs which were generally reviewed as for *Re-development* shall be the source of the LRs for 2019 Quarterly submission.

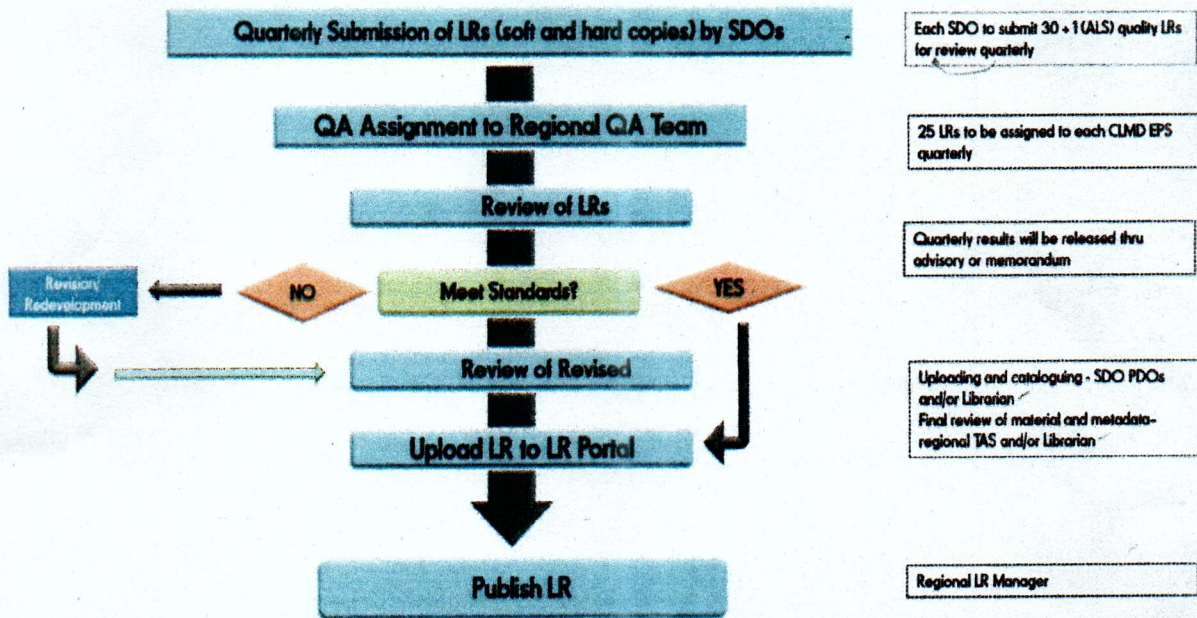




