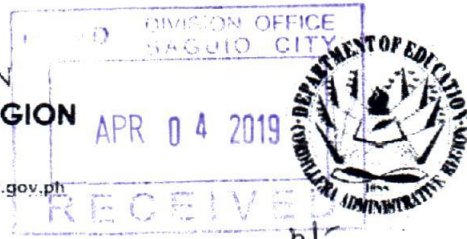

**SUBJECT :** FINANCIAL ASSISTANCE IN SUPPORT TO THE FAMILIES OF THE VICTIMS IN THE VEHICULAR ACCIDENT IN ZAMBOANGUITA, NEGROS ORIENTAL LAST MARCH 1, 2019

**DATE :** April 1, 2019

1. The Department of Education is looking for financial assistance in order to aid in the payment of bills and as support to the families of the victims in the vehicular accident in Zamboanguita, Negros Oriental last March 1, 2019 that claimed the lives of seven (7) students and hospitalized four (4) of them including their coach-teacher.
2. The victims are students of Basay National High School and were aboard a public utility van on their way home to Bayawan City following a competition in Cebu when the van collided with an oncoming truck transporting sugar cane.
3. Since the DepEd Central Office does not have funds for situations like this and while they are planning preventive and proactive measures for such, we are requested to raise funds to settle the hospital balance of the victims amounting to around PhP 3 million.
