**Contract Agreement Form**

THIS CONTRACT, made and entered into this 26<sup>th</sup> day of December, 2018 by and between the Department of Education, *Schools Division of Baguio City*, located at #82 *Military Cut-Off, Baguio City* represented herein by its *Schools Division Superintendent, FEDERICO P. MARTIN, EdD, CEEd, CESO V*, hereinafter referred to as the “Owner” of the one part and *RHOB Construction and Engineering Services*, represented herein by its *General Manager/ Proprietor, MR. ROBERT P. BAYO*, with office address at #523 San Vicente, Kennon Road, Baguio City, Beguet hereinafter referred to as the “Contractor” of the other part;

WHEREAS, the Entity is desirous that the Contractor execute *CY 2018 Quick Response Fund (Batch 2) Repair/Rehabilitation of Classrooms – Construction of Slope Protection at San Vicente Elementary School* (hereinafter called “the Works”) and the Entity has accepted the Bid for *Five Million One Hundred Seventy One Thousand Four Hundred Eighty Seven Pesos and 86/100 only (Php 5,171,487.86)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.


