### **Contract Agreement Form**

THIS CONTRACT, made and entered into this 26<sup>th</sup> day of December, 2018 by and between the Department of Education, *Schools Division of Baguio City*, located at #82 *Military Cut-Off, Baguio City* represented herein by its *Schools Division Superintendent, FEDERICO P. MARTIN, EdD, CEED, CESO V*, hereinafter referred to as the “Owner” of the one part and *MOMENT Diagram Builders*, represented herein by its *General Manager, MR. ROBERT DACLILI*, with office address at #418 Purok 1, Upper Km.3, Asin Road, Baguio City, hereinafter referred to as the “Contractor” of the other part;

WHEREAS, the Entity is desirous that the Contractor execute *CY 2018 Quick Response Fund (Batch 3) Repair/Rehabilitation of Classrooms – Construction of Slope Protection at Dominican-Mirador National High School* (hereinafter called “the Works”) and the Entity has accepted the Bid for *Five Million Two Hundred Forty One Thousand Eight Hundred Ninety Six Pesos and 43/100 only (Php 5,241,896.43)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.


bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


