



**BAC Resolution Declaring LCRB and Recommending Approval**

**RESOLUTION NO. 392, S. 2018**

**WHEREAS**, the Department of Education advertised the Invitation to Apply for Eligibility and to Bid of the CY 2018 QUICK RESPONSE FUND (BATCH 3) REPAIR/REHABILITATION OF CLASSROOMS – CONSTRUCTION OF SLOPE PROTECTION AT DOÑA AURORA NATIONAL HIGH SCHOOL and posted the same in the PhilGEPS and a conspicuous place at the premises of the Department of Education, Division of Baguio City;

**WHEREAS**, in response to the said advertisement, only THREE (3) contractors namely **HDG CONSTRUCTION & ENTERPRISES, MJLAC CONSTRUCTION and AGGREGATES, and MERJAN HAMBON GENERAL CONSTRUCTION** purchased Bid Documents and participated in the Opening of Bids on December 20, 2018;

**WHEREAS**, **MJLAC CONSTRUCTION and AGGREGATES** was disqualified due to non-submission of the Joint Venture document whether applicable or not;

**WHEREAS**, the bid proposal of the following were found to be substantially complying to wit:



### **Contract Agreement Form**

THIS CONTRACT, made and entered into this 26<sup>th</sup> day of December, 2018 by and between the Department of Education, *Schools Division of Baguio City*, located at **#82 Military Cut-Off, Baguio City** represented herein by its *Schools Division Superintendent, FEDERICO P. MARTIN, EdD, CEEd, CESO V*, hereinafter referred to as the “Owner” of the one part and *HDG Construction and Enterprises*, represented herein by its *General Manager/ Proprietor, MR. HANIVALL D. GUILANDO*, with office address at FD 232 Pines Park, Km 4, Balili, La Trinidad, Benguet hereinafter referred to as the “Contractor” of the other part;


bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


