BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 383, S. 2018

WHEREAS, the Department of Education advertised the Invitation to Apply for Eligibility and to Bid of the **CY 2018 QUICK RESPONSE FUND (BATCH 3) REPAIR/REHABILITATION OF CLASSROOMS AT QUIRINO HILL ELEMENTARY SCHOOL** and posted the same in the PhilGEPS and a conspicuous place at the premises of the Department of Education, Division of Baguio City;

WHEREAS, in response to the said advertisement, only **TWO (2)** contractor namely **MHIGS CONSTRUCTION** and **BENGUET BUILDERS** purchased Bid Documents and participated in the Opening of Bids on December 20, 2018;

WHEREAS, **BENGUET BUILDERS** was disqualified due to non-compliance with the sealing and marking of bids (2 envelope system) ;

WHEREAS, the bid proposal of **MHIGS CONSTRUCTION** was found to be substantially complying to wit:

Contract Agreement Form

THIS CONTRACT, made and entered into this 26th day of December, 2018 by and between the Department of Education, *Schools Division of Baguio City*, located at #82 *Military Cut-Off, Baguio City* represented herein by its *Schools Division Superintendent, FEDERICO P. MARTIN, EdD, CEEd, CESO V*, hereinafter referred to as the “Owner” of the one part and *MHIGS Construction*, represented herein by its *General Manager/ Proprietor, MR. MIGUEL A. KISWA*, with office address at # 27 Balacbac Central, Santo Tomas Proper, Baguio City, Benguet hereinafter referred to as the “Contractor” of the other part;

WHEREAS, the Entity is desirous that the Contractor execute *CY 2018 Quick Response Fund (Batch 3) Repair/Rehabilitation of Classrooms at Quirino Hill Elementary School* (hereinafter called “the Works”) and the Entity has accepted the Bid for ***One Million Six Hundred Eighty Six Thousand Four Hundred Sixty Nine Pesos and 71/100 only (Php1,686,469.71)*** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this Agreement, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Drawings/Plans;
 - (c) Specifications;
 - (d) Invitation to Bid;
 - (e) Instructions to Bidders;
 - (f) Bid Data Sheet;
 - (g) Addenda and/or Supplemental/Bid Bulletins, if any;
 - (h) Bid form, including all the documents/statements contained in the Bidder’s bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder’s response to request for clarifications on the

bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (i) Eligibility requirements, documents and/or statements;
- (j) Performance Security;
- (k) Notice of Award of Contract and the Bidder's conforme thereto;
- (l) Other contract documents that may be required by existing laws and/or the Entity.

3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
