



**BAC Resolution Declaring LCRB and Recommending Approval**

**RESOLUTION NO. 381, S. 2018**

### **Contract Agreement Form**

MARTIN, EdD, CEEd, CESO V*, hereinafter referred to as the “Owner” of the one part and *LOC Construction and Supply*, represented herein by its *General Manager/ Proprietor, Ms. LEONARDA O. CAPEGSAN*, with office address at 1B-43 Betag, La Trinidad, Benguet hereinafter referred to as the “Contractor” of the other part;
