



BAC Resolution Declaring LCRB and Recommending Approval

RESOLUTION NO. 127, S. 2018

WHEREAS, the Department of Education advertised the Invitation to Apply for Eligibility and to Bid of the **CONSERVATION AND RESTORATION OF GABALDON SCHOOL BUILDING AT AGUINALDO ELEMENTARY SCHOOL** and posted the same in the PhilGEPS and a conspicuous place at the premises of the Department of Education, Division of Baguio City;

WHEREAS, in response to the said advertisement, **TWO (2)** contractors namely **MOMENT DIAGRAM BUILDERS** and **ASS CONSTRUCTION** purchased Bid Documents and participated in the Opening of Bids on May 7, 2018;

WHEREAS, the bid proposals of the following were found to be substantially complying to wit:

WHEREAS, on May 17-18, 2018, the end-user conducted the post qualification or detailed examination of the bid of the lowest and responsive bidder namely **ASS CONSTRUCTION** who ranked first and **MOMENT DIAGRAM BUILDERS** who ranked second in the preliminary examination of bids on May 30, 2018;

WHEREAS, upon careful examination, validation and verification of the eligibility, technical and financial requirements that they have submitted, **ASS CONSTRUCTION** has been found to be non-compliant as to the requirements stated on the Bid Document's Technical Specifications (refer to Notice of Post Disqualification dated May 22, 2018);

WHEREAS, **MOMENT DIAGRAM BUILDERS** who ranked second in this bid, has been found to be in order in all respect, complying as to the technical specifications and financial requirements and is considered as the bidder with the lowest calculated bid;

NOW, THEREFORE, We, the Members of the Bids and Awards Committee, hereby RESOLVE as it is hereby RESOLVED:

- a) To declare **MOMENT DIAGRAM BUILDERS** as the Bidder with the Lowest Calculated and Responsive Bid in the amount of **SIX MILLION ONE**

Contract Agreement Form

THIS CONTRACT, made and entered into this 5th day of June, 2018 by and between the Department of Education, *Schools Division of Baguio City*, located at #82 *Military Cut-Off, Baguio City* represented herein by its *Schools Division Superintendent, FEDERICO P. MARTIN, Ed.D.C., Ed.D., CESO V*, hereinafter referred to as the "Owner" of the one part and *MOMENT Diagram Builders*, represented herein by its *General Manager, MR. ROBERT DACLILI*, with office address at #418 Purok 1, Upper Km.3, Asin Road, Baguio City, hereinafter referred to as the "Contractor" of the other part;

WHEREAS, the Entity is desirous that the Contractor execute *Conservation and Restoration of Gabaldon School Building at Aguinaldo Elementary School* (hereinafter called "the Works") and the Entity has accepted the Bid for *Six Million One Hundred Seventy Two Thousand Nine Hundred Forty Five Pesos and 56/100 only (Php 6,172,945.56)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conforme thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
