



BAC Resolution Declaring LCRB and Recommending Approval



Contract Agreement Form

THIS CONTRACT, made and entered into this 5th day of June, 2018 by and between the Department of Education, *Schools Division of Baguio City*, located at #82 Military Cut-Off, Baguio City represented herein by its *Schools Division Superintendent, FEDERICO P. MARTIN, Ed.D.C., Ed.D., CESO V*, hereinafter referred to as the "Owner" of the one part and *WWW Construction*, represented herein by its *Owner, MR. GLYNDON M. WAWEY*, with office address at Abatan, Bauko, Mountain Province, hereinafter referred to as the "Contractor" of the other part;

WHEREAS, the Entity is desirous that the Contractor execute *Electrification of Un-Energized Schools and Modernization of Electrical System of On-Grid Schools (Batch 2) at Irisan National High School* (hereinafter called "the Works") and the Entity has accepted the Bid for *Four Million One Hundred Fifty Six Thousand Nine Hundred Twenty Eight Pesos and 46/100 only (Php 4,156,928.46)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - (h) Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;


- (i) Eligibility requirements, documents and/or statements;
 - (j) Performance Security;
 - (k) Notice of Award of Contract and the Bidder's conformer thereto;
 - (l) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
 4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
