



**BAC Resolution Declaring LCRB and Recommending Approval**



**Contract Agreement Form**

THIS CONTRACT, made and entered into this 5<sup>th</sup> day of June, 2018 by and between the Department of Education, *Schools Division of Baguio City*, located at #82 Military Cut-Off, Baguio City represented herein by its *Schools Division Superintendent, FEDERICO P. MARTIN, Ed.D.C., Ed.D., CESO V*, hereinafter referred to as the "Owner" of the one part and *WWW Construction*, represented herein by its *Owner, MR. GLYNDON M. WAWEY*, with office address at Abatan, Bauko, Mountain Province, hereinafter referred to as the "Contractor" of the other part;

WHEREAS, the Entity is desirous that the Contractor execute *Electrification of Un-Energized Schools and Modernization of Electrical System of On-Grid Schools (Batch 2) at Sto. Tomas National High School* (hereinafter called "the Works") and the Entity has accepted the Bid for *Three Million Two Hundred Fifty Eight Thousand Three Hundred Fourteen Pesos and 25/100 only (Php 3,258,314.25)* by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

  - (l) Other contract documents that may be required by existing laws and/or the Entity.
