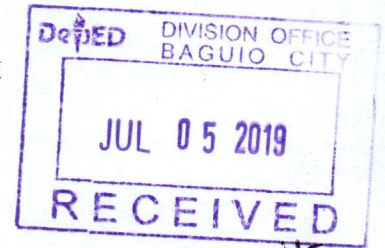

JUNE 2019 CRIMINOLOGISTS EXAMINATION RESULTS RELEASED

The Professional Regulation Commission (PRC) and the Professional Regulatory Board of Criminology have released the results of the June 9 to 11, 2019 Board Licensure Examination for Criminologists in thirteen (13) working days from the last day of examination.

Nationwide, 7,998 out of 20,797 examinees (38.47%) passed the examination. The results of examination with respect to seven (7) examinees were withheld pending final determination of their liabilities under the rules and regulations governing licensure examination. Pursuant to PRC Resolution No. 2004-223 dated July 19, 2004, results of examinations are final and request for reconsideration of failing grades is not allowed.

In Baguio, 1,180 out of 2,356 (50.08%) examinees successfully passed the examination.

Those who will register are required to bring the following: Online-generated Oath Form or Panunumpa ng Propesyonal, notice of admission or valid ID (for identification only), two (2) pieces passport-sized pictures (colored with white background and complete with name tag), and two (2) sets of documentary stamps.

Successful examinees should personally register and sign in the Roster of Registered Professionals.



ONLINE PROCEDURE
(updated as of July 2, 2019)

1. Log on to **online.prc.gov.ph** or **online1.prc.gov.ph**
2. Read the WEBSITE'S USER GUIDE
3. **For EXISTING ACCOUNT, click SIGN-IN**
4. Select Initial Registration and Certifications (if needed)
5. Select Preferred PRC Regional Office. Click **RESCHEDULE?** if you wish to change the system-generated schedule. **NO SAME-DAY APPOINTMENT POLICY. TRANSACT ONLY AT THE INDICATED APPOINTMENT PLACE**
6. Choose payment option (**LANDBANK, PAYMAYA, UCPB** (3-day validation) or **PRC CASHIER**). If you chose **PRC CASHIER**, pay only on your appointment date
7. Click **PRINT DOCUMENT** and **PRINTER ICON** to print for Oath Form and Order of Payment/Claim Slip for Certification
8. Proceed to the selected PRC Office on your appointment date to submit form/requirements
