



**B. Terms of Reference**

1. Private publishers with intention to commercialize the material shall submit prototypes to the DepED Central Office Bureau of Learning Resources Quality - Assurance Division for Assessment and Evaluation.
2. Private publishes with intention to donate text based learning resource for use as support and supplementary learning material in the K to 12 implementation of DepED shall submit prototypes for Review and Quality Assurance to the concerned CID-LRMDS of the Division for assessment prior submission to the CLMD-LRMDS of the Region.
3. The material shall be deemed part of LRMDS repository of Learning Resources and **NOT for SALE**.
4. By default, copyright of the LR belongs to the donatee and DepEd.
5. Terms and agreements shall be outlined to determine copyright ownership and scope of the donation on case to case basis.
6. The CID-LRMDS shall create QA team for this purpose.
