

RECOMMENDING THE AWARD OF CONTRACT THROUGH SMALL VALUE PROCUREMENT TO BRENTWOOD APARTELLE FOR THE CONDUCT OF LAUNCHING OF PROJECT DOVE AND RE-ORIENTATION ON THE ROLES OF MASTER TEACHERS

WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of meals and snacks with venue for the conduct of "Launching od Project DOVE and Re-orientation on the Roles of Master Teachers" with an Approved Budget for the Contract (ABC) of **Seventy Two Thousand Pesos only (Php 72,000.00)** (Annex A);

WHEREAS the proposal of **BRENTWOOD APARTELLE** is found to be the most compliant with the PR, and its price quotation amounting to **Seventy Two Thousand Pesos only (Php 72,000.00)** is the most economical and advantageous to the Government, thereby rendering the same as the lowest calculated responsive bid;

RESOLUTION RESORTING TO ALTERNATIVE MODE OF PROCUREMENT

WHEREAS the BAC received a request for the procurement of *meals and snacks with venue for the conduct of "Launching of Project DOVE and Re-Orientation on the Roles of Master Teacher"* with an Approved Budget for the Contract (ABC) of *Seventy Two Thousand Pesos only (Php 72,000.00)* (Annex A);

WHEREAS the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 mandates that all procurement shall be done through competitive bidding;

WHEREAS the same IRR of RA 9184 provides for exemption under Rule XVI – Alternative Methods of Procurement;

WHEREAS pursuant to Section 48 of the afore-cited Rule, the Department of Education – Division of Baguio City (DO) may resort to the alternative method of – *Small Value Procurement* to promote economy and efficiency if the amount involved does not exceed the threshold prescribed in Annex "H" of the IRR and does not fall under shopping in Section 52 of this IRR;
