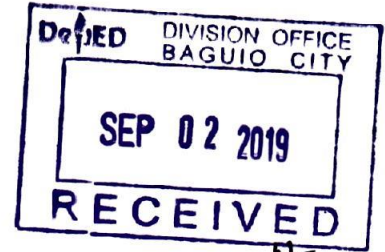

**ONLINE PROCEDURE**  
(updated as of July 2, 2019)

1. Log on to **online.prc.gov.ph** or **online1.prc.gov.ph**
2. Read the WEBSITE'S USER GUIDE
3. For **EXISTING ACCOUNT**, click **SIGN-IN**
4. Select Examination
5. Select Preferred PRC Regional Office. Click **RESCHEDULE?** if you wish to change the system-generated schedule. **NO SAME-DAY APPOINTMENT POLICY. TRANSACT ONLY AT THE INDICATED APPOINTMENT PLACE**
6. Choose payment option (**LANDBANK, PAYMAYA, UCPB** (3-day validation) or **PRC CASHIER**). If you chose **PRC CASHIER**, pay only on your appointment date
7. Click **PRINT DOCUMENT** and **PRINTER ICON** to print for Application Form
8. Proceed to the selected PRC Office on your appointment date to submit form/requirements

1. Original and photocopy of Transcript of Records with scanned picture and remarks, "For Board Examination Purposes";
2. Original and photocopy of PSA/NSO- Birth Certificate in security paper. Submit a copy of Birth Certificate from Local Civil Registrar if PSA/NSO copy is not legible;
3. Original and photocopy of PSA/NSO-issued Marriage Certificate in security paper. Submit a copy from Local Civil Registrar if PSA/NSO copy is not legible (for married female applicants only);
4. Regional Trial Court Clearance (valid until the last day of examination);
5. Valid NBI Clearance (valid until the last day of examination);
6. Three (3) Certificate of Good Moral Character from the following (valid until the last day of examination):
  - i. Barangay Chairman
  - ii. Parish Priest
  - iii. Dean of School
  - iv. Employer
7. One (1) piece RECENT passport-sized colored picture in plain white background with complete name tag (Last Name, First Name, Middle Name);
8. Any valid government-issued ID as competent proof of identity or Community Tax Certificate (Cedula); and
9. Documentary stamps with total face value of Php30.00;
