VILLA SILVINA HOTEL & RESTAURANT**

WHEREAS the Department of Education prepared the Purchase Request (PR) for the procurement of meals with accommodation for the conduct of "Writeshop on Contextualization of Learning Materials for Kinder and Grades 1-3" with an Approved Budget for the Contract (ABC) of **One Hundred Sixty Nine Thousand Pesos only (Php 169,000.00)** (Annex A);

WHEREAS on June 27, 2019, the DepEd – Bids and Awards Committee (BAC) posted/published the Request For Quotation (RFQ) for the said procurement project. The following suppliers/distributors signified their intent to participate by submitting their respective quotations/proposals, to wit:


