being the Approved Budget for the Contract (ABC) to payments under the contract for each lot/item. Bids received in excess of the ABC for each lot shall be automatically rejected at bid opening.

- 2. The Department of Education, Schools Division of Baguio City now invites bids for meals and snacks, or meals and snacks with venue, as the case may be, for each corresponding lot abovementioned. Delivery of the Goods is required on the date of the activity. Bidders should have completed, within at least 6 months from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

 In addition,
 - (i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from *Department of Education, Schools Division of Baguio City*, # 82 Military Cut-Off, Baguio City and inspect the Bidding Documents at www.depedpines.com or the address given during *Monday to Friday 8:00 AM 5:00 PM*.
