They also remind us that the <u>deadline for agencies to submit explanations/justifications for being unable to update PhilGEPS postings is on January 31, 2019 using the Annex 6.</u>"</p>

We would like to reiterate that non-compliance with the FY 2018 PBB requirements set forth by the IATF through MC 2018-1 shall warrant the entire agency's ineligibility to the grant of PBB, i.e. no PBB for all teaching and non-teaching personnel in DepEd; hence full attention and immediate action on the above-listed deficiencies are hereby appealed.
