ANG BATANG MATIBAY 2020 AWARDS

1. The Department of Education (DepEd), through the External Partnerships Service (EPS), in partnership with Nestlé Philippines Inc. (NPI)-Bear Brand Fortified Powdered Milk Drink signed a Memorandum of Agreement (MOA) in October 2017. One of the provisions of the MOA is the *Ang Batang Matibay Awards*. 


