Mechanics:

1. Open to enrolled Junior and High School Baguio students
2. Contestants will choose and bring their own medium on the day of the contest. They will be given illustration boards, 15 x 20 inches (1/4)
3. They will be given a maximum of 5 hours to complete their work. Food will be served to the participants (Snacks and Lunch)
4. The artworks should reflect the theme of the DAPC Week and shall judged with the following criteria  
Relevance to the theme -- 30%  
Creativity and Presentation . . .30%  
Originality. . . 20%  
Over All Visual Impart. . .20%
5. The works will all be displayed at The Podium Boutique Hotel from November 19 to 30, 2019 while awarding of winners will be on November 25, 2019 during the Flag Raising Ceremony at the Baguio City Hall Grounds.
6. The CADAC will be co-owners with the artist the final output of this activity. Chosen pieces/artworks will be developed as future IEC materials by the CADAC with proper acknowledgement of the artists.
