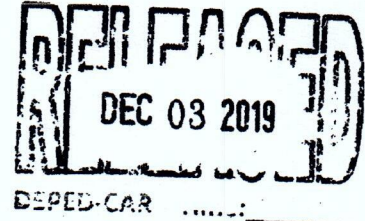

ADOPTING THE DEPED-CAR OFFICIAL SEAL

1. This office hereby reiterates the use and adoption of the official seal of DepED-CAR duly approved by the concerned authorities. The modification of the DepED-CAR seal is in accordance to the separation of Tabuk City as a schools division of Kalinga Province. This is pursuant to Republic Act 9404, *An Act Converting the Municipality of Tabuk into a Component City of the Province of Kalinga to be Known as the City of Tabuk.*
2. The DepED-CAR official seal shall be utilized in all official communications, and it shall be released to all DepED regional, division, district, schools and other field offices.
3. It may appear in four (4) colors or in black and white, and in different sizes with the following symbolism and specifications:

a. Seal Symbolism or Meaning

- The eight (8) rays of the sun emanate from the core center of the circle depicting the schools divisions of the region;
- The historic rice terraces as the background symbolizing the Cordillera as a landlocked region;
- The open book exhibiting the continuous quest for knowledge; and
- The lighted torch representing education as a guiding light eradicating ignorance.

b. Specifications

- **Color Representation**
- Yellow - Quest for knowledge
- Red - Burning desire to learn
- White - Peace
- Green - Love of nature

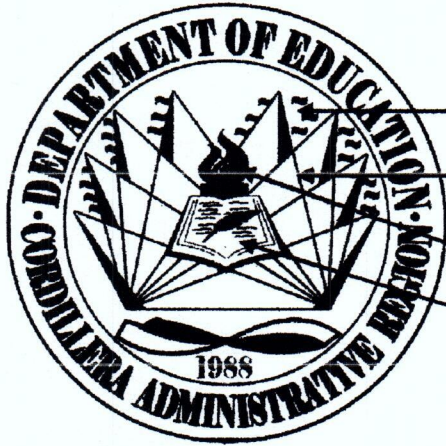
