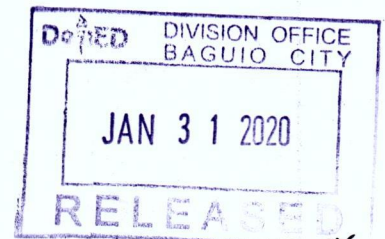

- d. Perform desired duties and responsibilities of coaches and officiating officials;



3. List of participants is enclosed for reference (*see Enclosure 1*)
